

# Tenable Raspberry Pi Contest

## Official Rules

### No Purchase Necessary to Enter or Win

- 1. Overview.** Tenable, Inc. (“Tenable”) has created a contest where participants will answer trivia questions on a Tenable website. If a participant answers 4 out of 5 questions correctly, he/she will pass the quiz. Once a participant passes the quiz, he/she will also need to fill-out a submission form to provide contact and shipping information. Of the eligible Entrants, a drawing will be conducted to identify the winners of a Raspberry Pi. The Contest is sponsored by Tenable and begins on November 2, 2021 at 12:00 am EST. Entries must be submitted during the Contest Entry Period (as defined below) to Tenable in strict accordance with Tenable’s instructions and these Official Rules. Participants are limited to a single entry during the Contest Period, but a participant may take the trivia questions over until they pass the quiz. Those who do not abide by these Official Rules or Tenable’s instructions or the prize fulfillment requirements may be disqualified at Tenable’s sole discretion. Tenable may keep all Entrant information after completion of the Contest for business management and record keeping purposes.
- 2. Eligibility.** The Contest is open only to all individuals who are 18 years of age or older; however, employees of Tenable and/or the immediate family (spouse, parents, siblings and children) and household members (whether related or not) of each such employee, Tenable channel partner employees, and federal and state government employees are not eligible to win the prizes described herein. No purchase of Tenable’s products or services is necessary to participate in the Contest. All federal, state and local laws (including international) and regulations apply and this Contest is void where prohibited by law.
- 3. Sponsor.** The sponsor and administrator of this Contest is Tenable, Inc., with its place of business located at 6100 Merriweather Drive, Columbia, MD 21044, United States of America. The Contest is no way sponsored, endorsed, or in association with creators of Raspberry Pi’s or the Raspberry Pi Foundation. Each Entrant completely releases and absolves Raspberry Pi Foundation and/or its affiliate from any association or liability of this Contest. - 4. Agreement to Official Rules.** Participation in the Contest constitutes Entrant’s full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 5. Contest Entry Period.** The Contest begins on November 2, 2021 at 12:00 am EST and ends on November 19, 2021 at 11:59 pm EST (the “Contest Entry Period”).

6. **Entry.** To enter the Contest, participants must answer 4 or more questions correctly out of 5 trivia questions on Tenable's hosted site: <https://www.tenable.com/nessus-on-raspberrypi>. Additionally, upon passing the quiz, each participant must fill out and submit a form at the event registration form accessed at the end of the quiz (accessed through the official event landing page, <https://www.tenable.com/nessus-on-raspberrypi>) (each an "Entrant"). The Contest is limited to one entry per person, and multiple entries by a single Entrant may void eligibility.
7. **Winners.** Entrants will be entered into a pool and winners will be selected randomly on November 22, 2021 at 12:00pm EST. If a potential winner did not comply with the Official Rules of this Contest, their entry will be void and Tenable will select an alternate winner in his/her place.
8. **Prizes.** There will be up to 200 winners receiving a Raspberry Pi (estimated value: \$115.00 USD). Tenable will notify the potential winners via email to the email address that the Entrant provides during registration. Winners may be required to provide evidence of identity in connection with claiming the prize.

If legitimately claimed, the prize will be awarded. All taxes, social security payments or other fees (including those applicable in your jurisdiction of primary residence) and other expenses not specified in these Official Rules as being provided as part of the prize are the sole responsibility of the winners. Winners must provide a valid address in order to receive the prize. Tenable will make reasonable efforts to ship the prize but may have limitations based on the Entrant's home country. Tenable will not replace and is not responsible for any lost, damaged, mutilated or stolen prize or any prize that is undeliverable or does not reach a winner because of an incorrect or changed address or other contact information. No transfers, prize substitutions or cash redemptions will be made. Tenable reserves the right to substitute the stated prize or portion thereof with another prize or portion thereof of equal or greater value (such as a gift card) for any reason, including, without limitation, prize unavailability.
